**\* Tiered NSF/Overdraft Privilege Fees:** We calculate the cost of NSF and any Overdraft Privilege (ODP) Service fees based on the number of NSF/ODP items processed as shown on the Fee Schedule per account (for example, a checking or share savings account). The more NSF/ODP items processed in a given timeframe (a rolling 12 month period), the higher the potential fee. The rolling 12 month period begins in the month and year when the first NSF/ODP item is processed. We continue to assess fees based on historical counts over a continuing 12 month period. **Example:** Assume, there are three separate NSF/ODP fees assessed in the same year (one in each month noted): September - fee is \$19 (begin rolling 12 month period); November - fee is \$19; December - fee is \$32. If no further NSF/ODP items are processed through December 1 of the following year, then the next NSF/ODP fee assessed would be \$19 and would begin a new rolling 12 month period.
